N O T I F I C A T I O N

Pursuant to Rule 39 of Arms Rules, 2016 and in supersession of the Notification previously issued vide **No. L.22012/1/2014-HMA dt. 19.05.2017**, the Governor of Mizoram is pleased to designate the following officials as **Accredited Trainer** for the jurisdictions mentioned below for the purpose of undertaking training course under sub-rule 1 of Rule 10 of Arms Rules, 2016. The designated **Accredited Trainer** shall have the power to issue a certificate in Form S-1 to the applicant on successful completion of the said course.

1.	Aizawl	1) Senior most Armourer in the Arms Kote of 1 st Bn. MAP, Armed Veng, Aizawl. 2) Senior most Armourer in the Arms Kote of 3 rd Bn. MAP, Mualpui, Aizawl. 3) Senior most Armourer in the Arms Kote of 5 th IR Battalion, Lungverh, Aizawl.
2.	Lunglei	Senior most Armourer in the Arms Kote of 2 nd Bn. MAP, Lunglei.
3.	Siaha	Post Commander from Mizoram Armed Police or Mizoram IR Battalion not below the rank of Sub-Inspector posted at Siaha.
4.	Kolasib	Senior most Armourer in the Arms Kote of 1 st IR Battalion, Mualvum.
5.	Mamit	Senior most Armourer in the Arms Kote of 4 th IR Battalion, Lungpawl, Mamit.
6.	Serchhip	Senior most Armourer in the Arms Kote of PTS, Thenzawl.
7.	Lawngtlai	Post Commander from Mizoram Armed Police or Mizoram IR Battalion not below the rank of Sub-Inspector at Lawngtlai.
8.	Champhai	Post Commander from Mizoram Armed Police or Mizoram IR Battalion not below the rank of Sub-Inspector at Champhai.
9.	Saitual	Post Commander from Mizoram Armed Police or Mizoram IR Battalion not below the rank of Sub-Inspector at Saitual.
10.	Khawzawl	Senior most Armourer in the Arms Kote of 2 nd IR Battalion, Khawzawl.
11.	Hnahthial	Post Commander from Mizoram Armed Police or Mizoram IR Battalion not below the rank of Sub-Inspector at Hnahthial.
12.	All Mizoram	Senior most Armourer in the Mizoram Police Central Armoury, Armed Veng, Aizawl.

Modalities for issue of Form S-1 to the applicant of Arm Licence:-

1. In the cases of Aizawl District, Lunglei District, Kolasib District, Mamit District, Serchhip District and Khawzawl District, the concerned DC to whom the application for issue of Arm Licence is submitted shall forward the details of the applicant to the Commandant of the Battalion concerned or Asst. Inspector General of Police (P&L), PHQ, Mizoram, Aizawl for necessary action.
2. In the cases of Siahla District, Lawngtlai District, Champhai District, Saitual District and Hnahthial District, the concerned DC to whom the application for issue of Arm Licence is submitted shall forward the details of the applicant to the Superintendent of Police of the District concerned or Asst. Inspector General of Police (P&L), PHQ, Mizoram, Aizawl for necessary action.
3. The Commandant/Superintendent of Police/Asst. Inspector General of Police (P&L) concerned shall requisition the service of Armourer/Post Commander as aforementioned to conduct safety training course for the applicant.
4. On completion of the training course, the Armourer/Post Commander, if he is satisfied, shall issue the certificate which shall be countersigned by the Commandant/Superintendent of Police/Asst. Inspector General of Police (P&L) concerned, without which the certificate is deemed invalid.
5. The training curriculum shall include the following modules:-
 - (a) Basic arms and ammunition safety practices including safe handling and carry procedures.
 - (b) Firing techniques and procedures.
 - (c) Care of arms and ammunition.
 - (d) Safe storage and transportation of arms and ammunition.
 - (f) Reasonable working knowledge of the provisions of Arms Act, 1959 and Arms Rules, 2016.
 - (g) Responsibilities of arms owner, particularly in relation to children.
6. If the type of firearm(s) required for his/her training purpose is not available at the disposal of the AIGP (P&L)/Commandant/Superintendent of Police concerned, the applicant shall be required to arrange the required firearm(s) on his/her own.

7. The Commandant/Superintendent of Police/Assistant Inspector General of Police (P&L) concerned shall arrange a shooting range as and when required.
