## **NOTIFICATION**

In the exercise of such authority, the following guidelines are to be adhered to:

- 1. Request for such certification shall be made by arecanut growers to their respective designated Certifying Officer.
- 2. Onsite verification shall be done by Certifying Officer /staff at convenient date(s) after which the Certificate of Origin shall be issued by the designated Certifying Officer as per the prescribed format at Annexure-I. All onsite inspection shall be conducted only in the presence of the arecanut cultivator or an authorized representative of the arecanut cultivator.
- 3. The Certificate of Origin will be valid for 10 (ten) days from the date of issue which shall be clearly indicated in the Certificate itself showing the start and end dates.
- 4. Any or all arecanuts found to be without the possession of such Certificate of Origin shall be deemed to be of foreign origin and liable for seizure.

- 5. The holder of the Certificate shall be treated as liable to criminal case if he/she misuses his/her Certificate of Origin.
- 6. The Certifying Officer shall be liable to disciplinary action/criminal proceedings if he/she is found to have misused his/her authority to certify arecanuts of foreign origin.
