Whereas a substantial number of duty posts of Mizoram Police Service (Junior Grade) have been lying vacant due to shortage of officers of the MPS (Junior Grade);

And whereas keeping such critical duty posts vacant hampers the efficient functioning of District Administration, District Executive Forces, and Mizoram Police in general, thereby causing problems in delivery of public services;

And whereas the Governor of Mizoram is satisfied that the operation of Rule 797 of Mizoram Police Manual, 2005 read with Appendix-XI which lays down that Probationary Deputy Superintendent of Police officers shall undergo practical training of 52 weeks' duration, hinders the Government of Mizoram in posting suitable officers to man critical vacant posts;

Now, therefore, in exercise of powers conferred under Rule 4 (3) of Mizoram Police Manual and in the interest of public service, the Governor of Mizoram is pleased to relax the provision of Rule 797 read with Appendix-XI of Mizoram Police Manual by reducing the duration of practical training presently undergone by the under-mentioned 8 (eight) Probationary Deputy Superintendent of Police Officers from 52 to 26 weeks to enable posting of these officers against the critical vacant posts.
