#### NOTIFICATION

**No.B.11016/1/2017 (S&RP)I, the 28<sup>th</sup> March, 2018.** Whereas, the Government of Mizoram is aware that certain insurgent groups are indulging in nefarious activities due to self perceived grievances and deprivations resulting in law and order problem in Mizoram and the neighbouring States.

Whereas, the Government of Mizoram is aware that these insurgent groups have been misguiding and indoctrinating the youths belonging to their community to take up arms and exhort them to adopt violent means as the only way to achieve their objective.

Whereas, the Government of Mizoram has decided to give full opportunity for the return of these insurgents to normal life and avail rehabilitation so as to live the life of law abiding citizens of the country;

The Government of Mizoram, therefore declared that all the insurgents who are indulging in illegal activities and resorting to arms struggle to achieve their objective will be given full amnesty if they return to normal life and declare their presence before Civil or Police Authorities. Rewards will be given for surrender of arms and ammunitions at the scales mentioned below.

**(1) FIREARMS**

**(2) AMMUNITION :**

(i)	RPG projectile/Mortar shell	:	Rs. 5,000/- per piece
(ii)	Landmine	:	Rs. 5,000/- per piece
(iii)	IED with timer device	:	Rs. 5,000/- per piece
(iv)	IED without timer device	:	Rs. 4,000/- per piece
(v)	Grenade	:	Rs. 3,500/- per piece
(vi)	Industrial explosive	:	Rs. 20/- per piece
(vii)	Industrial detonator	:	Rs. 15/- per stick
(viii)	Exploder	:	Rs. 3,000/- per piece
(ix)	Ammunition of UMG, LMG and other assault rifles	:	Rs. 20/- per piece
(x)	Ammunition of pistol such as 9mm, 7.65mm, etc.	:	Rs. 20/- per piece
(xi)	.22 ammunition	:	Rs. 10/- per piece

The reward specified above is the maximum to be given for serviceable weapons.

The quantum of rewards for surrender of arms and ammunitions of other description not specified herein including the final amount of reward in each case will be decided by the Director General of Police, Mizoram including serviceability of the weapons and the circumstances of the surrender.

The reward may also be granted to those persons who recover or capture or assist in recovery and capture of arms and ammunitions by furnishing vital information leading to such recovery or capture.

The granting of amnesty to surrendered insurgent will be decided on case to case basis and will not be applicable to those involving criminal activities and will be applicable to insurgents of Mizoram origin only.
