**ORDER**

Consequent upon the resumption of domestic flights and in view of the expected increase in the number of vehicles and passengers entering Mizoram through Vairengte, it is hereby ordered that all persons entering Mizoram through Vairengte shall abide by the following instructions with immediate effect and until further order.

1. Persons landing at Kumbhirgram Airport, Silchar shall make their own arrangement for their transportation from Kumbhirgram Airport, Silchar to Aizawl at their own expenses.
2. All passengers shall clear the mandatory medical screening at Vairengte check-gate and undergo quarantine as per the protocol prescribed by the State Government.
3. All passenger vehicles shall be thoroughly sanitised at Vairengte Check-Gate.
4. All passenger vehicles shall move in a convoy of at least 20 vehicles from Vairengte Police check gate till they reach the arrival points at Aizawl.
5. The vehicles moving in the convoy must not stop anywhere on the route till they reach the arrival points at Aizawl.
6. SDO (Civil), Vairengte shall inform all Deputy Commissioners, Mizoram about the details of vehicles and persons dispatched in every convoy from Vairengte including the number of vehicles with registration number and number of persons travelling in each vehicle.
7. Relatives or friends of passengers are not allowed to receive or welcome them anywhere along the route throughout the journey.
8. All persons arriving from Red zones shall undergo Rapid Antibody Test arranged by the receiving district administration and health authorities. PT-PCR test shall also be arranged as per the advice of health authorities.

The arrival point for persons bound for Aizawl District shall be R. Dengthuama Hall, Mualpui, Aizawl and for other districts shall be at Rajiv Gandhi Stadium, Mualpui. Transportation for other districts will be arranged by the respective Deputy Commissioners in consultation with The Task Group on Commodities & Transport.
