OFFICE MEMORANDUM

It has come to the notice of the Government that some Police personnel on duty at various Police Checkgates viz. Vairengte, Zokhawthar, Kanhmun, Medilicherra, Champhai Khankawn, Saiphai, Phaisen, Bairabi and New Kawnpui are in the habit of illegally collecting money from people/vehicles entering the state of Mizoram. This illegal collection of money without the sanction of the State Government is totally unacceptable. All Police personnel on duty at entry point checkgates aforesaid are instructed to stop such practice immediately.

Any violation of this instruction will be viewed seriously by the Government.

Further, any official or member of the public who witnesses any violation of this instruction may report (via whatsapp, email, sms etc) such violation to the undersigned for taking necessary action, and his/her identity will be kept strictly confidential. The concerned District Superintendents of Police should prominently display Notice near the checkgates in Mizo, English and Hindi as below:
